

eDoorways User Agreement

Introduction

Welcome to The Global Public Square, an online community created, operated and maintained by eDoorways International Corporation (herein referred to as "eDoorways"). By using The Global Public Square, its services and tools, you agree to the following terms with eDoorways International Corporation.

Accepting the Terms

Before you create and assume ownership of your own PowerChannel and its associated storefront in The Global Public Square you must read and accept all of the terms in and linked to this Agreement. By accepting this User Agreement you agree that it's terms and conditions will apply whenever you use The Global Public Square and the services of eDoorways. You also agree to abide by the terms and conditions established by the GPS PowerChannel Association and its members.

General Rules

There are rules that both guests of The Global Public Square and eDoorways PowerChannel owners must follow. These rules were created to protect you and your interests and to keep The Global Public Square safe for all members of our online community.

While using the eDoorways platform and The Global Public Square you agree that:

1. You are at least 14 years of age if you are a guest, and at least 18 years of age if you are the owner/operator of an eDoorways PowerChannel.
2. You have provided your User Profile information according to eDoorways' rules.
3. Your email address and contact information are valid and complete.

While using the eDoorways platform and The Global Public Square you will not:

1. Interfere with The Global Public Square site.
2. Use profanity.
3. Falsely report that another user or owner has violated an eDoorways or PowerChannel Association policy.
4. Misrepresent your identity.
5. Send spam or threats to other PowerChannel owner/operators.
6. Publish the contact information of other PowerChannel owners/operators.
7. Infringe on eDoorways' intellectual property.
8. Knowingly or willfully violate any international, federal, state or local statute.
9. Engage in the perpetration of fraud, illegal money laundering and activities associated with prostitution or other illegal sexual activities.

Rules for PowerChannel Owners

Your Rights

The notarized Grant Deed you are issued when you create a PowerChannel is your assurance that you are the legal holder of property that may appreciate in value. With ownership there are associated rights, duties and responsibilities. It is your right to:

1. Make modifications or improvements to your property. We are an open-API environment. As such, you can use the tools we offer or you can make use of tools and services provided by third parties.
2. Engage in commerce. You can sell your goods or services in The Global Public Market associated with our platform. In addition, you have the ability to reach out to the rest of the world through the links and tools we offer.
3. Share ownership with third parties. Any number of parties may own a PowerChannel subject to the age limitation as described in eDoorways "Terms of Use."
4. Market, advertise or promote your property, its capabilities and services. You can use the advertising and promotion tools we offer or you can draw upon third party tools and services.
5. Create ancillary sources of income, such as through subleasing to a third party. If you elect to sublease to a third party we require that you provide us with a copy of your lease agreement, which we will hold confidentially.
6. Create and operate sub-channels within your parent channel. You have the ability to create and operate as many sub-channels as you wish. All sub-channels must be created and registered with us. Third parties may hold ownership in sub-channels.
7. Determine who will visit or use your channel, and whether your channel will engage in public or private operations. The eDoorways platform gives you the ability to select who enters and uses your PowerChannel. We also give you the ability to operate your PowerChannel in privacy. In this context, your site operates as part of a closed community.
8. Place whatever content you wish in the channel. You can place any kind of content on your PowerChannel as long as no legal statutes are violated. We reserve the right to employ security measures such as electronic scanning to assure that you are not engaging in child pornography or other illegal activities such as money laundering.
9. Express your particular viewpoint or beliefs.
10. Engage in broadcasting. You can use your PowerChannel for video streamcasting. We reserve the right to charge you a broadband fee according to our established "Fee Schedule".
11. Engage in professional securities and financial service activities. Licensed securities and financial entities may conduct business activities on your PowerChannel.
12. Sell rights to your PowerChannel to a third party. You may sell your PowerChannel after you have held it for 12 months. eDoorways will serve as your exclusive agent in the transaction. We will help you sell it in our Marketplace, or you can sell it elsewhere. You must supply us with a copy of all relevant legal documentation associated with the sale. We will assure that the new owner receives appropriate ownership documentation. Our fee for this service is 5% of the net sales price.

As a PowerChannel owner/operator you have the right to establish a storefront and engage in ecommerce. Should you choose to do so, there are certain guidelines you must be aware of. You should review and understand the rules. If you fail to follow them you may be subject to a

number of consequences ranging from a limitation of your ability to engage in ecommerce transactions to the suspension of your account.

Selling Practices. As a seller, you are expected to:

1. Charge reasonable shipping and handling costs.
2. Specify shipping costs and handling time in the listing.
3. Follow through on your return policy.
4. Respond to buyers' questions promptly.
5. Be helpful, friendly, and professional throughout a transaction.
6. Make sure the item is delivered to the buyer as described in the listing.

Abusing eDoorways. If we think that users are creating problems in the community or if there is the possibility of legal liability we may limit, suspend or terminate our service and user accounts. We may prohibit access to our website and its content, services and tools, delay or remove hosted content, and take technical and legal steps to keep users off the website. At our discretion we may suspend or terminate accounts of users who may be repeat infringers of intellectual property rights of third parties.

eDoorways and The Global Public Square are working together to keep our website and services safe and in good working order. We encourage you to report problems, legal or policy violations and offensive content to us.

Fees and Services. Using the eDoorways platform and The Global Public Square is free. eDoorways charges a fee of 1% for all sales consummated on its platform. We reserve the right to charge fees for other services that we may offer. As a PowerChannel owner/operator you will have the opportunity to review and accept the fees that you will be charged if you elect to accept the service.

Content. You own all of the content that you create and post on your eDoorways PowerChannel. In the event that you give us content, you grant us a non-exclusive, worldwide, perpetual, irrevocable, royalty-free, sublicensable right to exercise any and all copyright, trademark, publicity, and database rights (but no other rights) you have in the content, in any media known now or in the future.

Limitation of Liability. You will not hold eDoorways or The Global Public Square responsible for other users' content, actions or inactions. You acknowledge that our platform is a venue to allow anyone to buy or sell goods and services at any time, anywhere, in a variety of forms. We do not transfer legal ownership of items from the seller to the buyer and are not involved in the actual buy-sell transaction. We have no control over and do not guarantee the quality, safety or legality of items you or other users may advertise, the truth or accuracy of users' content or listings, the ability of sellers to sell items, the ability of buyers to pay for items, or that a buyer or seller will actually complete a transaction or return an item. We cannot guarantee continuous or secure access to our platform and website, services and tools. The operation of our website may be interfered with by factor outside our control. To the extent legally permitted we exclude all implied warranties, terms and conditions. We are not liable for any loss of money, goodwill or reputation, or any special, indirect or consequential damages arising, directly or indirectly, out of your use of or your inability to use our platform and website, services and tools.

Indemnity. You will indemnify and hold us (and our officers, directors, and employees) harmless from any claim or demand, including reasonable attorney's fees, made by any third party due to or arising out of your breach of this Agreement, or your violation of any law or the rights of the third party.

Release. If you have a dispute with one or more users, you release us (and our officers, directors and employees) from claims, demands and damages (actual and consequential) of every kind and nature, known and unknown, arising out of or in any way connected with such disputes.

Legal Disputes. If a dispute arises between you and eDoorways or The Global Public Square our goal is to provide you with a means of resolving the issue quickly and economically. You and eDoorways agree that we will resolve any claim or controversy of law or equity that arises out of this Agreement or our services in accordance with this Legal Disputes Section or as you and we otherwise agree in writing. We will consider reasonable requests to resolve the dispute through alternative dispute resolution procedures such as mediation or arbitration as alternatives to litigation.

This Agreement shall be governed in all respects by the laws of the State of Texas as they apply to agreements entered into and to be performed entirely within Texas by Texas residents, without regard to conflict of law provisions. You agree that any claim or dispute you may have against eDoorways or The Global Public Square must be resolved exclusively by a state or federal court located in Travis County, Texas, except as otherwise agreed by the parties. You agree to submit to the personal jurisdiction of the courts located within Travis County, Texas for the purpose of litigating all such claims or disputes.

PayPal. You are required to use PayPal to facilitate your ecommerce transactions. Therefore, you must apply to become a PayPal merchant and be accepted by PayPal before you can become a vender on our platform. We reserve the right to offer additional payment fulfillment services. Should we do so, you have the right to change to the alternative service or to use all of the services we offer.

Resolution of Purchase Disputes

General. Buyers and sellers share the responsibility for making sure purchases facilitated by eDoorways are beneficial. We encourage buyers to work with sellers before opening a claim relating to a purchase. Sellers must have a reimbursement method on file with eDoorways. Sellers allow us to remove funds from their PayPal accounts for amounts due to buyers.

Resolution. We require sellers to comply with our resolution process. Buyers and sellers permit us to make a final decision, in our sole discretion, on any claim that a buyer files with eDoorways. If we resolve a dispute in the buyer's favor, we will refund the buyer for the full cost of the item (including any applicable sales taxes) and the original shipping, and we will require the seller to reimburse us for the amount due to the buyer. Sellers may not have to pay a reimbursement if they provide documentation (for example, delivery confirmation or proof that an item was as described).

eDoorways' Responsibilities

Services. We warrant that we will provide a reliable, stable and comprehensive operational platform and environment that complies with generally accepted and endorsed standards of

professionalism in the internet services industry. The nature and form of the services we provide may vary from time to time as we seek to enhance and improve our overall service offering. This may mean that, when appropriate, key functions, tools and services may be upgraded or replaced by newer, more effective approaches or services. We reserve the right to make such changes and improvements at our own initiative and at our sole discretion. In the event that a condition exists in which there has been a material adverse effect incurred by an eDoorways user we will take appropriate action to assure that the loss is effectively mitigated.

Privacy. eDoorways' Privacy Policy specifies how your personal information is used and protected. If you are a guest of eDoorways, you can browse our site and make purchases without telling us who you are. If you choose to register with our website as a registered guest or if you create a PowerChannel to become a PowerChannel owner we recommend that you review the eDoorways Privacy Policy. It is our policy that the information you create and that is created about you while you are at The Global Public Square belongs to you. Our Privacy Policy discusses the details of this policy and its implications to you and those with whom you interact.

Outage. It is eDoorways' policy that PowerChannel merchants will be compensated if The Global Public Square experiences an extended outage. In the event of a hard outage of two or more hours eDoorways will waive its 1% commission for any pending sales transaction.

General

If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be struck and the remaining provisions shall be enforced. Our failure to act with respect to a breach by you or others does not waive our right to act with respect to subsequent or similar breaches. We do not guarantee we will take action against all breaches of this Agreement.

We may amend this Agreement at any time by posting the amended terms on this site. Except as stated elsewhere all amended terms shall automatically be effective 30 days after they are initially posted. Additionally we will notify you on the eDoorways PowerChannel at www.edoorways.com. This Agreement may not be otherwise amended except in a writing hand signed by you and us. For purposes of this provision a "writing" does not include an email message and a signature does not include an electronic signature.

This Agreement sets forth the entire understanding and agreement between us with respect to the subject matter hereof. The following Sections survive any termination of this Agreement: Fees and Services (with respect to fees owed for our services), Release, Content, Liability, Indemnity and Legal Disputes.
